WHY IS THIS **IMPORTANT?**

Customs Authorities are increasingly requesting complete & accurate goods descriptions in order to perform security/safety screening even before shipments leave the origin country.



Air Cargo Advance Screening (ACAS)

The Air Cargo Advance Screening (ACAS) Program requires the submission of advanced air cargo information on shipments arriving in the United States from a foreign location.

As part of the ACAS program, participating carriers submit a subset of required pre-arrival air cargo data to CBP at the earliest point practicable and **prior to** loading the cargo onto aircraft destined to or transiting through the United States.

Import Control System (ICS)

ICS (Import Control System) is the electronic security declaration management system for goods destined to the European Union customs territory (both final destination or just transiting within the EU), intended to elevate mitigation of security related risks & possible terrorist threats, such as explosives hidden in consignments.

The new regulation as of 2021 requires data for every shipment to be submitted prior to loading on a flight into or transiting EU Member State.






WHY IS THIS IMPORTANT?

Waybill data including goods description is used by Regulators for safety/security screening process - from point of export, flight manifest to destination clearance

- Ensure that your shipment can be uplifted at origin with correct security/safety data.
- ✓ Avoid **potential fines, penalties or confiscation of goods** by Customs Authorities.
- ✓ Avoid unnecessary transit time & clearance delays on either export and/ or import for your business or for your end customers.
- Avoid shipments **held on bonded** storage & applicable charges, awaiting missing/wrong information to be provided.
- ✓ Improve your compliance towards Customs Authorities.
- ✓ Avoid unnecessary customer-service contact to request additional information.



GOODS DESCRIPTION GUIDELINES FOR AIR WAYBILL (AWB)

WHAT ARE ACCEPTABLE GOODS DESCRIPTIONS?

Customs Authorities make clear that descriptions must be comprehensive & precise enough to enable identification and classification of the goods.

In the following slides you can find a series of Unacceptable & Acceptable Goods Description examples; which will help to illustrate the expectations from Customs Authorities.

Goods descriptions must provide complete information on the goods' precise nature in sufficient detail and in plain language. Goods descriptions must be accurate to enable Customs Authorities to identify prohibited/ restricted goods as well as adequate risk profiling for safety and security reasons.
